When you enroll in AmeriHealth Caritas VIP Care (HMO-SNP), you get all of these extra benefits included with your plan for no additional cost.

Most of these benefits are not covered by Original Medicare and are not always offered by other health plans.

Over-the-counter (OTC) benefit

AmeriHealth Caritas VIP Care's OTC benefit includes a monthly allowance of \$200 to spend on OTC medications and products you need to stay healthy.

Members will receive a restricted spend debit card to be used for over-the-counter (OTC) items. This debit card may be used for items included in the OTC catalog, online ordering portal and/or qualified items at participating retail settings. Quantity purchase limits may be applied for high-demand items. There is no limit on the total number of items or orders a member may purchase. Any unused balance will automatically expire at the end of each month or upon disenrollment from the plan.



*Members who qualify based on socioeconomic (LIS) status may use \$200 of the monthly allowance towards qualifying food and produce at participating retail locations and/or FarmBox mail-order, item limits may apply and/or qualifying rent and utility services. Any unused balance will automatically expire at the end of each month or upon disenrollment from the plan.



Dental services

AmeriHealth Caritas VIP Care offers coverage for several dental procedures, including preventive and comprehensive procedures, with no copayment.*

When you enroll in AmeriHealth Caritas VIP Care, you will enjoy benefits like:

- \$0 copay for preventive services, such as:
 - Oral exams.
 - Cleanings.
- \$0 copay for comprehensive services, such as:
 - Non-routine services.
 - Restorative services.
 - Endodontics.
 - Fluoride treatments.
 - X-rays.
 - Periodontics.
 - Extractions.
 - Prosthodontics.
 - Oral surgeries.
 - Dentures.

* There is unlimited plan coverage each calendar year for preventive services and a benefit maximum of \$3,000 each calendar year for comprehensive services. You are responsible for amounts beyond the benefit limits. Some services may require prior authorization.



Vision services

- AmeriHealth Caritas VIP Care offers coverage for routine vision services and eye care, including \$0 copay for:*
 - One routine vision exam every calendar year.
 - Routine eyeglasses or lenses.

*There is a benefit maximum limit of \$350 every calendar year for routine eyewear including eyeglasses (lenses and frames) or contact lenses. You are responsible for amounts above the benefit limit.



Hearing services

AmeriHealth Caritas VIP Care offers coverage for hearing services, including \$0 copay for comprehensive services such as:

- Hearing exam.
- Hearing aid evaluation.
- Hearing aid fitting (\$1,500 for hearing aids every three years for both ears combined; non-implantable hearing aids limited to two hearing aids total [one per ear, per three calendar years]).
- Hearing aid batteries (80 batteries per hearing aid for non-rechargeable models every three years).
- All appointments must be scheduled directly through TruHearing.



Transportation services

AmeriHealth Caritas VIP Care offers enrolled members transportation services to health care providers' offices and other approved health-related locations for no additional cost. Benefits include:

- 100 one-way trips to plan-approved health-related locations per calendar year. Mileage limits may apply.
- Curb-to-curb transportation to plan-approved locations.
- Taxi, passenger car, wheelchair van, rideshare, and other types of transportation services to meet each member's physical needs.



Fitness benefit

As a member of AmeriHealth Caritas VIP Care, you will be covered for a fitness benefit through SilverSneakers® at participating locations. You have access to instructors who lead specially designed group exercise classes. You can take classes plus use exercise equipment and other amenities at participating locations nationwide.

In addition, SilverSneakers FLEX® gives you options to get active outside of traditional gyms (like at recreation centers, malls, and parks). SilverSneakers also connects you to a support network and virtual resources through SilverSneakers LIVE™, SilverSneakers On-Demand™, and a mobile app, SilverSneakers GO™.

Meals

Nutritional risk factors can significantly increase the likelihood of hospital readmission.

Enrollment with AmeriHealth Caritas VIP Care will allow you to have meals delivered to your home immediately following surgery or an inpatient stay in a hospital or nursing facility if you are homebound.

The meal benefit includes up to 14 meals per week for four weeks, for post-discharge meals that are tailored to meet nutritional needs of major health conditions. High-quality meals crafted by chefs and dietitians are shipped to a member's home in a temperature-controlled cooler and can be refrigerated up to two weeks or frozen up to three months.



24/7 Nurse Call Line

The 24/7 Nurse Call Line is available at no cost for members who have questions about health concerns or need health information. A caring nurse will provide you with a resource to recommend the appropriate level of care and answer your health-related questions like:

- Do I need to see a doctor?
- Is it safe to wait, or do I need care right away?
- What should I do if my symptoms get worse?
- What can I start doing at home to feel better?



MDLIVE® telehealth benefit

Getting to your health care provider's office isn't always easy. That's why we offer access to a telehealth provider called MDLIVE at no additional cost.

MDLIVE is a AmeriHealth Caritas VIP Care provider that offers our members access to health care professionals 24 hours a day, seven days a week, for medical care they need that is not an emergency. MDLIVE can connect members to a health care provider on a phone, tablet, or computer when their health care provider is not available to see them or does not offer telehealth.



MDLIVE is only for routine medical care. If you are having an emergency, call 911.

Referral and/or prior authorization may be required for some of the benefits listed in this booklet.

You must receive your care from network providers. In most cases, you will have to pay for care that you receive from an out-of-network provider.

Refer to the Evidence of Coverage for a complete description of plan benefits, exclusions, limitations, and conditions of coverage.

AmeriHealth Caritas VIP Care is an HMO-SNP plan with a Medicare contract and a contract with the Pennsylvania Medicaid program. Enrollment in AmeriHealth Caritas VIP Care depends on contract renewal. The pharmacy network and provider network may change at any time. You will receive notice when necessary.
